### ***Truth or Dare: Can You Prove Compliance?***

Running an information governance (IG) marathon is a long and often difficult process. Keeping compliant throughout the race is an important and influential aspect that is typically overlooked. Recent research shows that while 87% of organisations have some kind of formal records and information management (RIM) program, only 8% measure compliance. A framework of basic RIM risk controls can help set expectations and provide a means to evaluate performance, plan for remediation, and benchmark against business goals and other organisations. The old adage of “what gets measured is what gets done” holds especially true when considering the financial, legal, and security risks of the explosive volumes of information being created across your enterprise. The complexity of controlling and managing information requires more than a standard RIM staff to ensure compliance for your customers, regulators, and shareholders. This keynote session provides a blueprint for managing such a complicated web of information.

You will hear how one organization delivered effective records management (RM), e-discovery, and archiving services with the aim of improving ILG maturity and to meet legal requirements and reduce overall organizational risk. You will learn how the ILG team was established to develop and implement the programme: the ILG vision and supporting strategy, a new RM operating

model, a global retention schedule, a methodology to support user adoption, the approach to underpinning archive and data map services, and the approach to remediating historical unstructured data. ***Data Privacy & Information Security: Implementing Information Governance***

This session shows the necessity of an information governance framework that incorporates mechanisms to effectively tame big data. Achieving successful information governance (IG) within an organisation has its challenges. This session uses multiple case studies to demonstrate how technology and data analysis can be used as a tool to achieve successful IG. The case studies show how the implementation of an automated

disposition platform and a scan to document management system initiative provided effective methods of data analysis and achieving policy compliance. You can use a strategic plan to achieve IG compliance with the use of metrics to implement technologies for the greater good of IG and to reduce the risk and cost of superfluous data and an overall paper footprint in your own organisation.

***The E-Privacy Directive Review: Anticipating the Impacts – Room TBD***

The E-Privacy Directive (Directive 2002/58) is set for review. The EU Commission must decide whether the specific privacy rules for the electronic communication sector, which covers areas such as traffic, localization data, and cookies, should be maintained, removed, or extended. This is especially important in view of the adoption of the General Data Protection Regulation in December 2015. This session addresses questions such as the regulatory asymmetry between over-the-top (OTT) providers and mobile network operators (MNO), the risks of parallel rules on issues such as data breach notification or traffic and location data processing, and the extent and limits of the confidentiality of communications.

The transition into digital recordkeeping and information governance is challenging for both the organisations and the archival repositories. Public and private organisations use many enterprise content management (ECM) systems to handle their information and very few have functionality covering long-term storage needs. This case study walks you through a new archival architecture, being developed by the National Archives of Norway, that adds a layer between the ECM systems and the archival repositories – the eArchive. It will be possible for organisations to store all documentation as long as is needed and also easier for the archival repositories to receive and process transferred material because it's all coming from the same uniform solution.
